

Guest speaker agreement under the framework of specialist discussion

Entered into under paragraph 51 of Act N° 40/1964 Coll. Of the Civil Code as currently valid

and

Guest performer: **Simone Kaempf**

(hereafter referred to as “Guest”)

1 Subject of the Agreement

- 1.1 This Agreement sets out the conditions of participation in specialist discussions and performances organised by the SND as part of the Eurokontext festival from 17th to 20th, and related rights and obligations of the parties to the Agreement, and further facts derived from this Agreement.
- 1.2 The Guest undertakes to take part in the specialist discussion entitled **Major Challenges for Theatre Makers in the V4 Region** to be held on the 20th of June 2014 without seeking entitlement to compensation for the participation in the specialist discussion.
- 1.3 The SND undertakes to cover, on behalf of the Guest, the cost of their accommodation cost incurred in connection with their participation in the specialist discussion.

2 Guest accommodation cost

- 2.1 In return for the participation in the discussion, the SND undertakes, under Article 1 paragraph 1.2 of this Agreement, to reimburse the Guest for the real cost of accommodation from the 17th of June until the 20th of June 2014 in the hotel Crown Plaza.
- 2.2 The SND undertakes to reimburse the Guest for the real cost of travels from Berlin to Bratislava on the 17th of June 2014 and from Bratislava to Berlin on the 20th of June 2014.

3 Obligations of the parties to the Agreement

3.1 The SND undertakes:

- a) To cooperate with the Guest as required for their participation in the discussion;
- b) To provide adequate organisational and technical support required for the participation in the specialist discussion.

3.2 The Guest undertakes:

- a) To arrive to the specialist discussion at the latest 15 minutes prior to its start;
- b) To represent an online portal Nachtkritik.de.

- 3.3 The Guest grants the SND a consent to introduce their name and surname and their portrait photo, images, video and audio recordings concerning the Guest for the purpose of presentation and publicity of the specialist discussion under Article 1 paragraph 1.2 of this Agreement and/or SND activities, and that t be done by all commonly used means of presentation or publicity (such a publishing in electronic and print media, in printed material, on the teletext, on the Internet).

4 Final clauses

- 4.1 Legal facts not set out in this Agreement shall be governed by relevant clauses of the Civil Code or other generally binding regulations that are in force in the Slovak Republic.
- 4.2 This Agreement is endorsed for the fixed time period until 30.6. 2014. This Agreement may be terminated prior to the above date by giving notice without specifying the reasons by any of the parties to the Agreement. The termination of this Agreement shall come in force on delivery of the written notice to the other party to the Agreement.
- 4.3 Any changes and amendments to this Agreement shall be made upon mutual consent in writing by numbering and signing the amendments.
- 4.4 The parties to the Agreement declare that they have entered into this Agreement on their true and free will, with certainty, seriously and clearly, not under pressure or in any other otherwise obviously adverse circumstances. The parties to the Agreement declare their capacity and liberty to enter into this Agreement, and that their capacity related to engage in legal deeds is in no way limited or disqualified. At the same time they declare that they are familiar with the content of this Agreement and have signed it thus indicating their consent.
- 4.7 This Agreement is of confidential nature. The parties to the Agreement undertake to retain confidentiality about its content and all facts related to this Agreement.
- 4.8 This Agreement is made in five (5) equal copies, one for the Guest and four for the SND.
- 4.9 This Agreement becomes valid on the day of its signing by the parties to the Agreement and shall enter into force on the day of its publication under a separate regulation.
