## Loan Agreement

Between (loan giver)

the following agreement is concluded.

### § 1

The loan giver places the following objects at the loan receivers' disposal from  
until

for the exhibition:

**Anton Cepka in Slovak National Gallery in Bratislava, from 10.03.2016 until  
05.06.2016**

The loan objects may only be used for the above mentioned purpose. Every change of safe-keeping requires the written approval of the lender.

### § 2

The object has to be returned to the lender unasked and without delay at the end of the exhibition, but not later than by the end of the loan period.

### § 3

The transport from Munich to Bratislava will be done by Petra Hölscher by car. The transport from Bratislava to Hanau will be done by IGS-hs art service.

§ 4

The loan receiver is obliged to handle the loan objects with greatest care, to keep them from damage, and not expose them to any danger.

§ 5

The loan objects must not be altered in any way.

§ 6

The loan giver has to be informed immediately of any change or damage to the loan objects. A record of the kind of damage must be made.

§ 7

The loan receiver declares that the loan object, including transport, will be insured to the value stated by the loan giver, taking into account the full liability under § 8 and accept insurance of the loan object from \_\_\_\_\_ until the end of the exhibition.

§ 8

The loan receiver is obliged to compensate to the loan giver any damage on the loan objects that occur during the loan period.

§ 9

In other respects the regulations of the BGB on loan apply. Both the loan giver and loan receiver receive one copy of the loan agreement.
