### **General provision**

The parties to this Agreement declare that they are legal entities qualified to conclude this Cooperation Agreement.

## **I Subject of the contract**

The subject matter of this Agreement is the cooperation of its parties in the following:

Cooperation on preparing the guest performance Someone Else's Heart in the framework of Nová drama/New Drama Festival on 13 May 2016 at 7.00 p.m. in Studio of Slovek National Theatre

(hereinafter only "events")

## **II The rights and liabilities of contractual parties**

*1<sup>st</sup> Party to this Agreement is obliged:*

1. to include the event in the programme of the Nová dráma/New Drama Festival 2016,
2. to provide and cover travel expenses of stuff and set in amount of **1 100.- € (one thousand one hundred Euros)** after receiving an invoice from the 2<sup>nd</sup> Party to this Agreement
3. to provide favourable technical conditions for the production: see Attachement 1 – a technical rider of the production.
4. to provide special services required (fireman, usherettes, cloakroom services. etc.) during the performance in cooperation with Slovak National Theatre..

*2<sup>nd</sup> Party to this Agreement is obliged:*

1. To perform 1 (one) theatre performance on 13<sup>th</sup> May 2016 at 7.00 p.m., in the Studio of Slovak National

Theatre, address: Pribinova 17, Bratislava,

2. To provide and transport to the place of performing all technical equipment needed for realizing the performance according to Attachement 1 provided by 2nd Party (in Attach.: „provided by the Guest)

3. Technical requirements of 2<sup>nd</sup> Party to this Agreement, which were not listed in the contract, will not be additionally provided and covered by 1st Party to this Agreement.

### **III Final provisions**

1. The contractual parties agree to provide the necessary cooperation at fulfilling of this Agreement.

2. This Agreement is concluded for a definite period. The agreement shall become effective on the day following its publishing in the Central Register of Contracts and shall close on 13 May 2016. The royalty is due after receiving and invoice from the 2<sup>nd</sup> Party and payable not later than on 16 May 2016.

3. This Agreement becomes valid on the day of its signing by both sides and comes into effect on the day following its publication in the Central Registry of Contracts.

4. According to the valid income tax act, the author will fulfill his tax liability in his country.

5. This Agreement is executed in two copies, each copy having the effect of the original. Each Party to this Agreement shall receive one copy of this Agreement after it is signed.
