### **PARTIES**

Pontificia Università Gregoriana located in Italy and Trnava University located in Slovak Republic hereby enter a cooperative agreement of exchange and collaboration, commencing with the academic year 2017-2018.

### **OBJECTIVES**

The objectives of this Memorandum of Understanding (MOU) may include but will not be limited to:

1. Formal Collaboration for the purpose of unilateral or bilateral Study Abroad programs;
2. Student Exchange agreements facilitating exchange for specific courses, disciplines and research;
3. Staff Exchange agreements for both academic and administrative staff;
4. Collaborative curriculum development to facilitate the implementation of Student Mobility programs;
5. Other forms of academic collaboration including research, development and delivery of joint courses;
6. Exchange of information including library materials and research publications; and
7. Joint participation in internationally funded projects.

### **IMPLEMENTATION**

The implementation of this MOU will be specified in accompanying schedules development from time to time by mutual agreement of the parties.

All financial arrangements, if any, will be subject to negotiation and prior written approval.

### **GENERAL**

This MOU is a statement of understanding and is not intended to create binding or legal obligations on either party. Each party retains all rights, titles and interest to its own work and any intellectual property rights therein. This agreement does not give either party any license of use or right over the intellectual property of the other party. The use of trademarks and/or denominations representative of either party is strictly prohibited without the owner's prior written consent. Both parties will request approval from each other before releasing public statements relating to the other party.

Where a problem or dispute arises between the parties they will first seek to resolve that dispute between themselves and will use their best endeavours to settle the problem or dispute by direct negotiation. Where the problem or dispute continues the parties may elect a third party by mutual consent, who shall examine the problem or dispute and provide recommendations. All expenses incurred in appointing the elected third party shall be shared equally by the parties.
