### PREAMBLE

#### *Subject of the contract*

Subject of the contract is cooperation between the contracting parties specified above (Philharmonic, Foundation) on implementation of the concert of the Slovak Philharmonic with the conductor Daniel Raiskin and the violinist Sergei Dogadin, which will be held within the 72<sup>nd</sup> concert season of the Philharmonic (2020/2021) on June 18, 2021 at the Concert Hall of the Slovak Philharmonic.

### Article 1

#### *Obligations of the contracting parties*

##### **3.1. Philharmonic undertakes:**

a) to secure venue, orchestra, conductor Daniel Raiskin within the cooperation and all necessary for successful course the concert at the Concert Hall of the Slovak Philharmonic (basically, to ensure complex management of the concert in question).

- b) to cover the 4\* hotel accommodation of Sergei Dogadin in Bratislava for the period of the rehearsals and concert.
- c) to ensure the transportation for Sergei Dogadin from Vienna to Bratislava and back.
- c) to publish the logo of the Foundation and mark it with "Concert in cooperation with" on promotional materials issued for the event.
- d) to provide 4 free tickets for the concert for the guests of Foundation.
- e) to provide the audio and audio-video recording of the concert to the Foundation, which can use it for non-commercial promotional purposes only and to publish the recording of the work "Seascapes" on the YouTube channel of the composer Alexey Shor.

### ***3.2. Foundation will be responsible for:***

- a) communication with the agents of Sergei Dogadin (Harrison Parrott)
- b) covering the concert fee of Sergei Dogadin for his appearance as soloist in the work "Seascapes" by Alexey Shor, as well the financial compensation of the internet live-streaming of the concert realized by the Slovak Philharmonic and the radio broadcast realized by the Slovak State Radio and Television
- c) cooperation with Philharmonic on promotion of the concert in question, e.g. by publishing information on the concert on all information sources available


## **Article 2**

### ***Final provisions***

1. The contracting parties undertake to fulfil their obligations properly, on time and to cooperate efficiently with each other.
2. This agreement is valid from the date of its signing by the contracting parties, it is subject to mandatory publication in accordance with the Act of the National Council of the Slovak Republic No. 211/2000 Coll. on free access to information, as amended, and is effective on the day following the day of its publication.
3. In case that one of the contracting parties fails to perform its obligations, it is obliged to notify the other parties without undue delay.
4. The agreement shall be drawn up in two originals, one for each party.
5. The agreement is concluded for a definite period – it ends on the day of fulfilment of the obligations of all parties.
6. The agreement may be amended only by mutual agreement of all parties and only in writing.
7. The relations regulated by this contract are governed by the legal legislation valid in the Slovak Republic.
