#### **Agreement on Cooperation**

# Entered into pursuant para. 51 of Act 40/1964 Coll. of the Civil Code (hereafter the "Agreement") by

## **1** Subject to the Agreement

- 1.1 This Agreement sets out the conditions for the provision of cooperation between the convenors of the festival and its Guest within the framework of the Eurokontext.sk festival, related rights and responsibilities, as well as other facts deriving from this Agreement.
- 1.2 The Guest agrees to publicise the Eurokontext.sk festival to be held from 12 to 21 June 2017, by his participation at the festival, giving interviews and objective statements without entitlement to a fee.
- 1.3 In compensation for his participation at the festival and publicity pursuant the Agreement, the SND shall reimburse the Guest for accommodation and travel expenses arising in connection with his participation at the festival and activities pursuant this Agreement.

#### 2 Guest accommodation and travel cost

- 2.1 In case of participation of the Guest at the festival in person and in order to assure proper provision of services by the Guest in line with Article 1 point 1.2 of the Agreement, the SND shall provide for and cover the cost of accommodation for the Guest.
- 2.2 In case of participation by the Guest at the festival in person and following proper provision of services by the Guest, pursuant Article 1 point 1.2. of this Agreement, the SND shall reimburse the actual and documented expenses incurred by the Guest. The Guest shall arrange for his travel tickets. The SND shall, upon presentation of relevant documents related to travel expenses and cost, reimburse the Guest with the agreed amount. All expenses (particularly tax on non-cash income) related to the payment of the amount documented by the Guest, shall be borne by the SND. The Guest shall receive the total amount actually incurred to cover the cost.

## **3** Commitments of the parties to the Agreement

- 3.1 The SND shall:
  - a) Provide the guest with assistance required for his participation at the festival and for activities set out in the Agreement;
  - b) Meet relevant organisational and technical requirements for the participation at the festival and activities set out in the Agreement.
- 3.2 The Guest shall:
  - a) Follow the instructions by the SND to fulfil his commitments pursuant Article 1 point 1.2 of the Agreement;
  - b) Present the SND with document/documents supporting a tax domicil for payment from SND according to the Agreement and expenses incurred in connection with travel to attend the festival and to deliver services in line with Article 1 point 1.2 of the Agreement.

3.3 The Guest grants the SND a consent to provide his name and surname, and his portrait photograph, images, audio and visual recordings for the purposes of publicity pursuant Article 1 point 1.2 of the Agreement and/or SND activities by all common presentation or publicity means (e.g. publication in electronic and print media, printouts, on the teletext and on the internet).

## 4 Final clauses

- 4.1 Legal issues not set out in the Agreement shall be governed by relevant clauses of the Civil Code and other legal regulations applicable in the Slovak Republic.
- 4.2 The Agreement is entered into for a fixed term, for the duration of the festival and until the completion of activities pursuant the Agreement, by 30 June 2017 at the latest. The Agreement may be terminated prior to the above deadline with cancellation period of 14 days that shall begin on the day of delivery of the cancellation notice to the other party to the Agreement. In case of cancellation of the Agreement prior to the arrival of the Guest to the festival, as well as in case of the failure by the Guest to attend the festival, the SND is entitled to adequately reduce or not reimburse the Guest with a part and/or the entire sum representing accommodation and travel cost.
- 4.3 Any changes and amendments to the Agreement shall be executed upon mutual agreement in writing with amendments duly numbered and signed.
- 4.4 The parties to the Agreement declare that they have entered into the Agreement on their own and free will, with certainty, seriously and clearly, not under duress or other evidently adverse circumstances. The parties to the Agreement declare that their ability and liberty to enter into the Agreement, as well as capacity to engage in related legal acts has not been in any way limited or inhibited. At the same time they declare that they have been familiarised with the Agreement and in expression of consent they are signing the Agreement.
- 4.7 The Agreement is confidential. The parties to the Agreement shall retain in about its content and any facts related to the Agreement.
- 4.8 The Agreement is made in five (5) equal copies, one of which shall be retained by the Guest and four by the SND.
- 4.9 The Agreement takes effect on the day of its signing by both parties to the Agreement and shall come into force on the day of its publication in line with a specific legal regulations.
