

COOPERATION AGREEMENT ON HOLDING EXHIBITIONS AT THE SND

1 Terms to the Agreement

- 1.1. This Agreement covers the definition of rights and commitments of the Parties in implementation of the exhibition “**title**” in the premises of the SND New Building.

Title: “**Addicted to water**”

Venue: e.g. SND New Building, 3rd floor, Opera and Ballet wing

Date: 14.th September – 30.th October 2017

- 1.2. SND and the Exhibitor have agreed on cooperation in implementing an exhibition.
- 1.3. Within the framework of cooperation hereof, the Parties shall bear the status of co-organisers of the exhibition.

2 Implementation of the exhibition

2.1. “**Addicted to water**”

3 Rights and obligations of the Parties

- 3.1. **The Exhibitor** undertakes to carry out and meet the cost of:
- selection of exhibits,
 - preparation of exhibits,
 - graphic design of invitation and other publicity material presenting the exhibition and use the SND logo on all publicity material related to the exhibition;
 - assure delivery of invitations via email to invited guests;

- prepare output (publicity material) for approval;
- transport of the exhibits in coordination with the SND to the venue of installation;
- arrange and implement the installation of exhibits in the dedicated SND venues;
- arrange for the opening of the exhibition in cooperation and conjunction with the SND;
- dismantling of the exhibition and removal of exhibits within the agreed deadline;
- installation of the exhibition in the dedicated venue at the SND in a manner to prevent damages and to restore the venue to its original state after dismantling the exhibition;
- dedicate a person responsible for the organisation and coordination of activities on its behalf, contact: **Martin Aigner**,
- inform on its website and social media about the exhibition in all output as a matter of joint Project;
- settle copyrights related to all exhibits,

3.2. **SND undertakes to:**

- approve the exhibition titles and time schedule of the exhibition;
- enable access to the venue to install the exhibition within the agreed deadline;
- dedicate a person responsible for the organisation and coordination of activities on behalf of the SND: **Mgr. Branislav Stanček**
- to inform on its website and social media about the exhibition as a matter of joint project;
- approve print outputs;
- provide venue for the exhibition opening and arrange for audio equipment there;
- to place publicity material related to the exhibition (poster) in the SND Box Offices located in the SND New and Historical Buildings.

4 Financial conditions

- 4.1. The Parties have agreed that their cooperation pursuant Article 1 hereof in implementation of the exhibition as set out in Article 2 hereof shall be free of charge. The Parties shall bear the status of co-organisers of the exhibition
- 4.2. The Parties have agreed and by signing this Agreement confirm that they shall meet the commitments pursuant Article 3 hereof at their own cost, and no Party shall request its counterpart to provide any financing for commitments set out in Article 3 hereof.

5 Other provisions

- 5.1. The Parties undertake to provide each other with interoperability of the performance of this Agreement.
- 5.2. The Agreement is concluded for a fixed period starting on the date of signing the Agreement by both Parties and lasting until 30th October 2017.
- 5.3. The Agreement may be terminated by either of the Parties without establishing the grounds, with a notice period of 30 days commencing on the day of its delivery to the other Party. In the event of termination of the Agreement, the Parties are required to settle mutual obligations arising under this Agreement without delay after the delivery of the notice.
- 5.4. The Parties agree and the Exhibitor acknowledges that, if necessary, the SND shall be entitled to relocate the exhibition under way from the venue set out hereof to other comparable venue within the SND building. SND shall notify in advance the dedicated person by the Exhibitor – Martin Aigner about the change of venue thereof. In the event the Exhibitor fails to cooperate, the SND shall bear no responsibility for any damages that might arise from the relocation of the exhibition.
- 5.5. The Parties have agreed that each Party shall independently bear responsibility for compliance with commitments under Article 3 hereof, and for any damages that might arise. SND shall bear no responsibility for the displayed exhibits, installation, transport or any other circumstances concerning the displayed exhibits, or for any possible damages that might occur to the displayed

exhibits, for any breach of or risk to copyrights related to the displayed exhibits or for any other breach of legal regulations by Marin Aigner.

6 Final provisions

- 6.1. Any amendments to this Agreement shall be made by mutual agreement in the form of written amendments, numbered and signed by both Parties.
- 6.2. In case of change of generally binding regulations, the relevant provisions of this Agreement shall be brought into compliance with the applicable legislation in the form of Appendix.
- 6.3. The Agreement is made in 3 (three) equal copies, of which one copy shall be retained by the Exhibitor and two by the SND.
- 6.4. The Parties herewith declare that they have entered into the Agreement on the basis of free will, seriously and comprehensibly, not in distress or under otherwise strikingly adverse circumstances.
- 6.5. The Parties herewith state that their capacity to enter into this Agreement as well as the ability to relevant legal act is in no way limited or excluded, and, at the same time, they declare that they have familiarised themselves with the content of this Agreement and are signing it, thus indicating their consent.
- 6.6. This Agreement shall enter into force upon signature by both Parties and into effect on the day following its publication in the Central Register of Contracts (CRC).
