

## ENGAGEMENT LETTER (Mandate Contract) No. SF 27/2017

concluded pursuant to § 724 and the subsequent sections  
of the Civil Code (Občiansky zákonník) as amended

between the Contracting Parties:

### Article I. Subject of Letter

- The Mandatary undertakes by this Engagement Letter to participate as jury chairman in the 8th International J. N. Hummel Piano Competition, held in Bratislava in the period September 17-24, 2017 and based on his expertise he undertakes to evaluate the professional and artistic qualities of the applicants.
- In the performance of his job, the Mandatary obliges to act to the best of his knowledge.
- The Mandatary obliges to assess the applicant's performance by keeping scores on a score-card to be submitted to him. The Mandatary will assign scores independently and exclusively upon his own discretion.
- The Mandatary obliges to perform the job personally and he is not authorised to appoint a substitute.
- The competition will act accordingly, only in case when 20 competitors will be subscribed at least.

**Article II.  
Remuneration**

- The Contracting Parties agreed that the Mandator will pay the Mandatary a remuneration amounting 2.716,- Eur gross (in words : two thousand seven hundred and sixteen Eur gross), from which the Mandator will, in accordance with the valid regulations of the Slovak Republic, deduct tax instalment of 19%, that is 516,-Eur tax and 2.200,-Eur net.

- The Mandator undertakes to ensure and pay the Mandatary's accommodation in Bratislava for the period September 17-24, 2017 (7 nights), 1/1 room.

**Article IV.  
Final Provisions**

- The Contracting Parties declare that they have attentively read the Engagement Letter; that they understood its content and that they agree with the Letter without any objections and unconditionally - in recognition whereof they personally sign it.
- This contract shall be valid from the date of the signature by the contractual parties and become subject to the mandatory disclosure in accordance with the Act of the National Council of the SR No.2011/2000 Coll. on Free Access to Information and Amendments. The contract shall be effective the next day after being published (on the internet).
- The rights and duties of the Contracting Parties not regulated by this Engagement Letter shall follow the applicable provision of the Civil Code (Občiansky zákonník).
