### have agreed to conclude this contract under the following conditions:

#### Article I.

## The subject mater of this contract

1.1. By this agreement, the contracting parties undertake to cooperate in the preparation and implementation of the professional theatre event Andrej Kurejčík Drama Laboratory in the period February 16<sup>th</sup> - February 23<sup>rd</sup> 2022 in the place of the Theatre Institute Studio 12 on Jakubovo námestie 12 in Bratislava.

#### Article II.

## The duties of the contracting parties

2.1. By this contract, the contracting party 1, as the organizer of a professional theatre event, undertakes to ensure contracting party 2:

- 2.1.1 To provide the space of the Theatre Institute of Studio 12 on Jakubovo námestie No. 12 in Bratislava for the professional theatre event Andrej Kurejčík Drama Laboratory in the period of February 16<sup>th</sup> to 23<sup>rd</sup>, 2022 daily for 3 hours according to the mutual agreement with the contracting party 2 at the expenses of the contracting party 1.
- 2.1.2. To provide the material and technical support for the event, including the service of technicians for the duration of the professional theatre event according to point 2.1.1 of this contract at the expenses of the contracting party 1.
- 2.1.3. To reimburse contracting party 2 the contract amount in accordance with clause 2.2.1 of this contract.
- 2.2. By this contract, the contracting party 2 as the implementer of the professional theatre event, undertakes to carry out the agreed cooperation for Contracting Party 1:
- 2.2.1. Preparation, professional leading and realization of a professional theatre event Andrej Kurejčík Drama Laboratory in the period of February 16<sup>th</sup> 23<sup>rd</sup> February 2022 in the space of the Theatre Institute Studio 12 lasting 3 hours a day (always in agreement with the contracting party 1) for a fee of 575, € including VAT (in words five hundred and seventy-five euros including value added tax) which will be sent to him by cashless transfer to the account number specified in the header of this contract after the end of the event.
- 2.2.2. Contracting party 2 as a taxpayer, together with contracting party 1 mutually agreed not to apply of the tax withholding pursuant to § 43 para. 14 of Act no. 595/2003 Codex on income tax, while the remuneration within the meaning of this contract is taxed by the taxpayer himself through a tax return.

### Article III.

### **Final Provisions**

- 3.1 The duration of his contract is in effect for a definite period until February 28th, 2022
- 3.2 The contract comes into validation as off the day of the signature of the both parties and into effect on the day following the day of its publication in The Central Register of Contracts at the Government Office of the Slovak Republic.
- 3.3 The contract is issued in two originals and each contracting party obtains one exemplar.
- 3.4 All changes and amendments to this contract can be made only by mutual agreement and must be put in written form and must be agreed and signed by persons authorized to act on behalf of both the contracting parties.
- 3.5 All issues not covered by this contract are to be governed by the relevant provisions of the law of the Slovak Republic.
- 3.6 The contracting parties declare that they read the contract, understood the statutes of the contract and those are a demonstration of their real serious and free will confirming it by their vet-ink signature.
