General provision

The parties to this Agreement declare that they are legal entities qualified to conclude this Cooperation Agreement.

Article I Subject of the Agreement

The subject matter of this Agreement is the definitions of the rights and obligations of both parties arising in the connection with organizing of the Round Table Meeting and General Assembly of the nongovernmental organisation of ENICPA (European Network of Information Centres for the Performing Arts), which will be held in Bratislava at the date of November 9-10th,2017.

Article II Financing of the project

Both parties to this Agreement are obliged to realize the activities referred to in Article III of this Agreement in their own name at their own expenses

Article III Obligations of the Parties to this Agreement

The parties to this Agreement agree to cooperate in the following fields:

- 1. Divadelný ústav (The Theatre Institute) will ensure:
 - accommodation of foreign guests of the annual ENICPA Round Table Meeting and General Assembly in at least 2 hotels in Bratislava with preferential prices for representatives of the ENICPA network at the costs of participants themselves
 - lease, resp. rental of meeting and presentation rooms for expert contributions by representatives of ENICPA member institutions and for the General Assembly of a nongovernmental organization ENICPA on 9 and 10 November 2017 in Bratislava
 - coordination of the event
 - in cooperation with the ENICPA Board compiling of the expert contributions programme presented by the representatives of ENICPA member institutions
 - providing technical equipment according to the requirements of the ENICPA member institutions representatives in connection with their expert contributions
 - provision of catering within the agreed range; it means 2x lunch on 9th and 10th November 2017 and snacks in the range: coffee, tea, mineral water and small bakery during the negotiations on 9. and 10.11.2017
 - tickets for the evening cultural programme on 9 and 10 November 2017 (theater/concert) promotion of the event through its own website www.theatre.sk and electronic newsletter

2. ENICPA will ensure:

- The participation of the ENICPA member institutions representatives and of the ENICPA network Board at the annual Round Tabler Meeting and General Assembly of the ngo ENICPA at the date of the 9. and 10.11.2017 in Bratislava
- moderating the event
- in cooperation with the organizer of the event Divadelný ústav (The Theatre Institute) compiling of the expert contributions programme presented by the representatives of ENICPA member institutions
- the provision of catering within the agreed range; it means 1x dinner on 9. 11.2017 in the chosen restaurant (in the amount of maximum to 500,-€) and a snack after the final negotiations 10.11.2017 (in the amount of maximum to 100,-€)
- the promotion of the event through the own web page www.enicpa.info
- 3. The contracting parties undertake to provide each other mutual assistance in the implementation of this agreement. In the event that any of the contracting parties violates the provisions of this agreement, it is obliged to reimburse the affected party to the contract demonstrably damage.
- 4. Each party is solely responsible for the commitments into which it enters in relation to third parties.

Article 4
Final Arrangements

- 1. Any changes and amendments to this contract must be put in written form and must be signed by both statutory representaives of the contracting parties.
- 2. This Agreement is executed in two copies, each copy having the effect of the original. Each party to this Agreement shall receive one copie of this Agreement after it is signed.
- 3. The Agreement shall enter into force on the date of signature by both contracting parties and effective on the day following its publication in the Central Register of Agreements. The contract is obligatory published in the sense of § 5a of Act no. 211/2000 Z. z. on Free Access to Information and on amendments to certain acts as amended. The Parties acknowledge and agree that this Agreement, including any amendments thereto, will be made public.
- 4. The contracting parties declare that they have read this Agreement before it has been made public, that it has been concluded by mutual agreement on the basis of their free will, not in time and other disadvantages.
