The subject of the Contract is the performance of the theatre show "360° Virtual Puppetry – DER ERLKÖNIG" at the International Festival Bábkarská Bystrica 2022. (Puppetry Bystrica 2022.) held from 26th September to 2nd October 2022 in Banská Bystrica (hereinafter referred to as the "Festival").

Rights and Obligations of the Contract Parties

The Theatre Ensemble undertakes to:

a) perform the theatre show:

Date: 27th September 2022

The beginning of the stage construction: 26th September 2022 at 3-6 P.M., Performance space rehearsal: Základná škola, Ďumbierska 17, Banská Bystrica, at 27th September 2022 at 7-8 A.M.

Dismantlement of the stage, venue vacating: 27th September 2022 at 5 P.M.

b) perform the show on the top artistic level;

- c) provide the Organizer with promotion materials for the show;
- d) send the certificate to the Festival regarding the settlement of copyrights and pertaining author honorariums for presentation of the show at the Festival;
- e) inform on presentation of the theatre show at the Festival via web-page and theatre programme poster and to ensure promotion of the Festival (promotion banner, mention in a relevant section of web-page, active link at www.bdnr.sk, indication of date and logo of the Festival on a monthly programme poster, etc. as agreed);
- f) allow recording of the show for the Organizer's documentary purposes;
- g) allow photography of the show for the Organizer's documentary purposes;
- h) inform the dramaturgy (Jaroslav Voľanský, bdnr.dramaturgia@gmail.com, +421907807999) on interviews provided to media during the Festival. While providing the interviews the Theatre Ensemble shall ensure that the media will inform on participation of the Theatre Ensemble or an artist at the Festival;
- i) allow TV and broadcasting staff the recording for newscast, information and promotion purposes free of charge;
- j) provide the Festival with information on technical and organizational requirements;
- k) in the event the Organizer is not able to arrange all technical and special requirements mentioned in the list of technical requirements of the theatre, to ensure own technical equipment and special technical equipment, as agreed;
- adjust time of construction and dismantling of the stage according to time conditions of the Festival;
- m) in cooperation with technical staff of the Festival to ensure due test of interpreting equipment or subtitling equipment;

- n) ensure necessary stage properties that are inevitable for the show performance, as agreed;
- o) inform the Organizer on type of insurance policies of all members of the ensemble and technical staff. The Theatre Ensemble is fully responsible for complete insurance of all persons and property of the theatre during its stay at the Festival.

The Organizer undertakes to:

- a) provide the Theatre Ensemble with required technical conditions and theatre show conditions;
- b) ensure that the stage in Základná škola, Ďumbierska 17, Banská Bystrica will be ready on 26th September 2022 from 3 P.M. and ensure necessary services on the day of the performance (fireman, cloakroom, usherette);

c) ensure the promotion-advertising of the show in all Festival materials;

- d) provide necessary technical staff as the service for the show (lighting technician, sound engineer, stage technician);
- e) ensure advance sale and regular sale of tickets for the show;

f) ensure the agreed beginning of the show;

- g) provide and bear costs of accommodation with breakfast in 2 single rooms for the ensemble members – in total of 2 people (1 men/ 1 women) from 26th September 2022 to 28th September 2022, i.e. 2 nights.
- h) The Festival participant is liable for all costs that result from cancelling prebooked accommodation.
- i) provide and bear costs of meals for the ensemble members in total 1 meal per full day for 2 people from 26th September 2022 evening to 28th September 2022 lunch.

III.

Financial Settlement

- 1. The Organizer undertakes to make payment of the honorarium for the presented show to the Theatre Ensemble in the amount of 2 222,22- EUR / in words. Two thousand and two hundred twenty two Euro. Twenty two cent. From this sum the Organizer has to deduct STAGE TAX in the amount of 422,22,- EUR, which will be paid to the Slovak Tax Authorities. Amount of 1. 800,- EUR will be transferred to the bank account of the Theatre Ensemble by official invoice.
- 2. The sum of the agreed honorarium mentioned above relates to .3.. presented theatre shows. Such agreed honorarium includes all expenses concerning

the theatre show, including incidental expenses and it is the final sum.

- 3. The Organizer undertakes to make payment to the Theatre Ensemble the proven costs associated with the performance /transport of people, equipment, material, scenes, props/ max. in the amount of 300,- EUR after submitting the following documents:
- travel documents /tickets, boarding passes/ or proof of purchase /invoice, cash sales pad/ in case of use of regular transport /bus, train, airplane/
- vehicle technical licence with an indication of the average consumption per 100 km and proof of purchase of fuel in case of use of a motor vehicle
- invoice for the ordered transport services /including the date and time of the trip, route and distance/ and bank statement in case of use of transport services on invoice
- bank statement or proof of payment

The cost of local transport at the festival venue or the cost of the driver /salary, meals, accommodation/ will not be paid by the Organizer.

The Theatre Ensemble shall submit the required documents as an annex to the invoice issued by Theatre Ensemble referred to in paragraph 3.

The Organizer is obliged to make payment of the honorarium agreed in this Contract for the theatre show performed properly and in time upon presentation of the invoice issued by the(theatre ensemble) within 14 days maturity period of receiving the invoice via bank transfer to the bank account of the Theatre Ensemble kept in

V. Final Provisions

a) The Organizer may cancel the contractually agreed theatre show (or participation of the Theatre Ensemble at the Festival) no later than 30 days in advance of the performance date and without any claim of the Theatre. Ensemble to payment of contractual fine. The Organizer have to pay the flight tickets already purchased.

b) The Theatre Ensemble has the right to cancel the show only in the event of serious illness of some of the main protagonists, if there is no possibility to ensure proper replacement so that the show retains the required standard.

c) In the event the Theatre Ensemble cancels the show for the reasons mentioned in par. b) Article V. herein or for any other reasons, it is obliged to compensate to the Organizer the costs arising during the preparation of the show and the costs that are necessary for replacement of the show, if the sum of these expenses is higher than contractually agreed honorarium mentioned in Article II herein. In such event the Theatre Ensemble is obliged to pay to the Organizer the difference between the costs pertaining to alternative programme and the agreed amount of honorariums as per this Contract. Such agreed compensation shall be due upon the invoice issued by the Organizer after the performance of the other than the agreed show.

VI. Extreme situations – COVID-19, war conflict

a) Neither of the Contracting Parts shall be liable for the non-performance of the term and / or the improper execution – in whole or in part – of any obligation under this agreement if the non-execution or inappropriate execution of the obligation was caused by an extreme situation, as defined by law.

b) The part invoking an extreme situation is required to notify the other part within 3 days of the occurrence of the event and take all possible measures to limit its

consequences.

c) If, within 3 days of production, that event does not cease, the parts have the right to notify the termination of this Agreement without any right to claim any damages.

VII.

- a) Any changes or amendments to this Contract have to be in writing and approved upon signing by both Contract Parties.
- b) The Contract is made in three originals, two originals shall be for the Organizer and one original for the Theatre Ensemble.

- e) Both Contract Parties undertake to fulfil consistently the conditions of the Contract and thus to ensure the success of the Festival.
