

Contract

Concluded between

- **Bratislavské Regionálne Ochranské Združenie (BROZ)** (Na Riviére 7/a, 84104, Bratislava, Slovak Republic) and
- **Metropolitný inštitút Bratislavy** (Primaciálne námestie 429/1, 81499 Bratislava, Slovak Republic, ID No.: 52324940, Tax No.: 2120982490) as the Contractor according to the following terms and conditions.

The Contractee will complete the following tasks for project CSO-Ia/2019/410-363 Game Over? Do not let climate change end the game (DEAR Programme), budget line 5.7.1. Speaker fees:

- preparing and realization of presentation for press conference on climate change, including handout for journalists.

Event will take place on **October 4th 2022 in Bratislava.**

Bratislavské Regionálne Ochranské Združenie (BROZ) pays for the implementation of the tasks described above up to **120 EUR (one hundred twenty Euro)** as a total (gross) fee for the Contractor with the financial support of European Commission. The established fee includes all the costs of the Contractor, which are directly related to the above-mentioned tasks. The Contractee is responsible to pay all tax related charges.

The total installment (120 EUR) will be paid through bank transfer to the Contractee, once the presentation will be prepared and presented, and handout will be sent to BROZ, as agreed with Bratislavské Regionálne Ochranské Združenie (BROZ) and after the successful completion of the agreed tasks and the delivery of the outputs as defined above. The Contractor has the right to request returning full or part of the fee in case of no completion of the task.

The Contractee shall include in all his communications related to the activities described above that they have been implemented with the support of European Commission and in partnership with Bratislavské Regionálne Ochranské Združenie (BROZ) and that the donor is not responsible for the expressed views and the use of information made available (disclaimer).

The Contractee shall complete the above tasks fully in line with the contract. Bratislavské Regionálne Ochranské Združenie (BROZ) can reduce the fee if the activities have not been carried out in line with the agreement, or the quality of work does not meet its professional expectations.

In case of breach of any provisions of this contract by the Contractee, the Contractee agrees to compensate Bratislavské Regionálne Ochranské Združenie (BROZ) for any damages or loss resulting out of such breach, and Bratislavské Regionálne Ochranské Združenie (BROZ) will withhold payments and/or recover the amounts already paid.

Any settlements of dispute not regulated by the present contract are solved according to the relevant Slovak laws and regulations.

The present contract was written in two identical original copies; it was read by the contracting partners and signed as a document fully in line with their will.
