- if the waste shipment or recovery has not been completed as intended or if it has been effected as an illegal shipment, the person who arranges the shipment or the consignee – if such a person is not able to complete the waste shipment of or its recovery:
  - a) shall take the waste back or shall ensure the waste recovery in an alternative way; and
  - h) provide for the waste storage in the meantime.

- 2. the person who arranges the shipment shall be obliged to ensure that the waste is accompanied by the document contained in Annex VII,
- 3. the documents contained in Annex VII shall be signed by the person who arranges the shipment before the shipment takes place and shall be signed by consignee when the waste in question is received by the installation arranging its recovery.
- 4. the herein contract shall be effective when the shipment of the waste starts,
- 5. The herein contract shall remain effective during the period of the shipments taking place in accordance with the documents contained in Annex VII, until the recovery operation in the installation is completed,
- 6. The person who arranges the shipment or consignee shall provide a copy of the herein contract upon request by the competent authority concerned.
- 7. In plastic waste, classified under the code EU3011, the content of contamination will not exceed 6% of the total maximum weight of a given batch, in accordance with the Correspondent Guidelines No. 12 of 12<sup>th</sup> November 2021.
