CONTRACT

AN AGREEMENT made 10th December 2022 with Mr. Frantishek Čavojský for DOM KULTURY, Shkolska 118-1,92600 Sered .Slovakia IČO: 31 8717 98 DIČ: 202 100 5965 hereinafter referred to as The Purchaser and Abbie Carter of the Hal Carter Organisation, 41 Horsefair Green, Stony Stratford, Milton Keynes, MK11 1JP England hereinafter referred to as The Management.

WITNESSETH that The Purchaser hereby contracts The Management to provide the services of the band professionally known as **SLADE** hereinafter referred to as The Artiste on one (1) engagement in **SLOVAKIA** on the date and venue, the fee and conditions as defined in the following schedule.

It is agreed the guaranteed fee shall be £12,500.00 GBP (twelve thousand five hundred pounds sterling) paid nett and free of all local and national taxes, surcharges, airport taxes and bank transfer fees. Such guaranteed fee to be paid to The Management by bank transfer to the Hal Carter Organisation Account as follows: £5000.00 GBP (five thousand pounds sterling) paid immediately upon contract, £5000.00 GBP (five thousand pounds sterling) to be paid no later than 24th February 2023 and the balance of £2500.00 GBP (two thousand five hundred pounds sterling) to be paid no later than 22nd May 2023.

Pandemic Clause - Please note, the band members, performers, crew or management cannot be held accountable if a pandemic situation arises and they are not able to perform or travel. Quarantine in the country of the performance/departing country or arriving country will not be acceptable and therefore the contract will become null and void.

However, if this should arise during this Active contract, the promoter will have to cover any costs (accommodation, loss of earnings, food etc) in the country of the performance. In the case of a pandemic the artists will have the right to cancel this contract prior to departure and will not be held responsible for any charges or costs incurred by the promoter. In the case of a pandemic, should the Artists cancel this contract, the Artist/management will return the fees paid less any costs the Artists/management has incurred through flights/travel.

It is agreed that the deposited amount is non-refundable except in the case of breach of contract by The Management and/or The Artiste.

Dates of engagement: 24th June 2023

Venue: Open Air Event, Sered, SLOVAKIA

Performance time: TBC (Running order to be agreed)

<u>Venue information and performance time to be confirmed to the Management by</u>
<u>The Purchaser immediately after contracts have been exchanged.</u>

Additional clauses:-

1. It is agreed the Management will book and provide flights.

- 2. It is agreed that The Purchaser will arrange, provide and pay for first-class internal transportation which will comfortably transport eight (8) persons together with their luggage. (Please note they travel with eighteen (18) pieces of luggage and equipment comprising of large suitcases, peli-cases, guitar flight hard cases etc It is also agreed that the Artiste will NOT travel in the same vehicle as the backline at any time.
- 3. It is agreed that The Purchaser shall provide accommodation shall provide accommodation in first class hotel of a minimum four stars throughout the duration of the Artistes stay, such accommodation to comprise eight (8) Iarge double en-suite rooms executive/business class rooms (no single beds)) at bed and full English breakfast rate, (please note each hotel room must have two (2) bottless of still mineral water provided for each guest at no cost to the artiste), such hotels to have the facility of a bar and restaurant. **As agreed the travelling party will arrive on Friday 23rd June 2023 and depart on Sunday 25th June 2023**

The Purchaser shall provide at no cost whatsoever to the Artiste lunch and dinner including drinks for eight (8) persons each day for the full duration of the artistes stay in a first class restaurant/hotel at a time to be agreed with the Artiste or the option of a buy out of €35 Euros per person per day.

It is agreed that it is the sole responsibility of The Purchaser to pay for and ensure that all necessary permissions, visas and work permits are acquired so as to allow The Management and The Artiste to fulfil their contractual obligations.

It is further agreed that on exchange of contracts The Management will provide The Purchaser with all necessary information and documentation so as to arrange and acquire such permissions.

- 4 It is agreed The Artiste shall perform one (1) show at the contracted venues such show to be of sixty (60) minutes maximum duration including an encore.
- It is agreed that The Purchaser at his sole expense shall provide and pay for The Artistes technical requirements as defined in the attached Technical Rider/s including PA, backline and lights.

Any failure by The Purchaser to meet the requirements contained in The Artistes Technical Rider will immediately release The Management and The Artiste from their contractual obligations without prejudice to the fee being paid in full.

- 6. The Management agrees to furnish The Purchaser with all publicity material as may be reasonably requested and will furthermore ensure The Artiste is available wherever possible to participate in promotional activity so as to help ensure the success of this engagement.
- 7. The Purchaser warrants that in the interests of himself and both the Artiste and the Management he will hold Public Liability Insurance of not less than US \$5,000,000 (five million US dollars).

- 8. It is agreed that any re-booking of The Artiste by The Purchaser will be negotiated via The Management for a period of eighteen (18) months following the completion of this engagement.
- 9. It agreed and understood that the performance of the Artiste is the sole copyright of the Artiste and that recording such by audio, video or any other means is unlawful and may result in the Artiste terminating the performance in which case payment of the full contracted fee shall be due.
- 10. It is agreed and understood that in the event of cancellation by the Purchaser, the artiste is to receive 50% of their contracted fee. This cancellation fee increases to 100% if the Purchaser cancels within five (5) weeks of the performance date.
- 11 It is agreed and understood than in the event of disagreement the matter shall be judged and decided according to the Laws of England whose court shall be the exclusive court of jurisdiction.

I/WE having read and fully understood the contents of this Contract and any accompanying Rider hereby confirm that the requirements contained herein are of the utmost importance and that they will be strictly adhered to in detail. Any breach of the terms and conditions of this Contract or the attached Artistes Rider shall render this Contract null and void.
