

**AMENDMENT TO THE THIRD-PARTY COST SHARING AGREEMENT BETWEEN THE SLOVAK REPUBLIC (THE DONOR) AND THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)**

With reference to the Third-Party Cost Sharing Agreement between the Slovak Republic (the “Donor”) and the United Nations Development Programme (“UNDP”) and together with the Donor, the “Parties” signed on 21 December 2017 (the “Agreement”), the Parties hereby agree on the following:

WHEREAS the Donor hereby agrees to contribute additional funds, in amount of 700.000 USD to UNDP on a cost-sharing basis for the implementation of the Transformative Governance and Finance Facility II Project, as described in the Project document and the concept note “Unlocking Inclusive Innovation in Cities” and in line with the amended budget and multi-year work plan;

WHEREAS the Parties wish to amend certain provisions of the Agreement;

NOW THEREFORE, the relevant provisions of the Agreement indicated below are hereby amended in order to be complemented as follows (“Amendment 1”):

**Article I. The Contribution**

1. (a) The Donor shall, in accordance with the schedule of payments set out below, contribute to UNDP the amount of 3.7 million USD. The Contribution shall be deposited in USD to the following bank account:

The Donor shall transfer to UNDP an additional contribution of 700,000 USD (together with the initial contribution of the Agreement, the total “Contribution” is 3,700,000 USD), in line with the schedule of payments of the present Amendment.
