

- The artist's tax residency is Austria. The presenter will send VAM a detailed statement showing all deductions (taxes, etc.). The promoter takes care on FEU-tax forms when FEU Tax has been withholded and will send it to VAM.
- 10. All fees in connection with the performance such as hiring of music material, performing rights, VAT will be paid by the presenter
- 11. Presenter will provide 10 complimentary tickets for the artists. In addition, the artists will receive program booklets and a concert poster.
- 12. All audio and / or video recordings are subject to an additional agreement except recordings with a length of maximum 5 minutes for advertising purpose.
- 13. In case of a cancellation of the performance due to force majeure, no party is authorized to demand compensation. In case of illness of the artist, the artist provides a medical confirmation and the artist will be replaced by a replacement. Should the concert not take place for act imputable to the presenter the artists will be entitled to receive the total amount mentioned in clause 6. Should the concert not take place for act imputable to the artists the presenter will be entitled to receive a max. Indemnity equal to the amount referred in clause 6.
- 14. VAM will provide up to date advertising materials, such as biographies, booklets and high resolution photos. The presenter must only use material either provided, or authorized by VAM. The artists are available for interviews.
- 15. The presenter will send all concert reviews to VAM within one week of appearance.
- 16. The attached rider is full part of this agreement.
- 17. Any dispute and / or difficulty arising from interpretation and / or execution of this agreement, shall, if the parties fail to reach an amicable agreement, be settled before the relevant competent courts in Vienna.
