

AGREEMENT

For the SILVER SPONSORSHIP and EXHIBITOR of the Polymer Meeting 15

between

Preamble:

PISAS is the main organizer of the scientific conference Polymer Meeting 15 held on September 4-7 2023 in Bratislava (<https://pm15.sav.sk/>), covering various aspects of polymer science. Around 12 plenary lectures, 40 invited lectures, giving floor also to young established scientists, 60 contributed lectures and 150 posters from all around the world are expected. Thus, the Polymer Meeting 15 will be one of the major polymer conferences in Europe in year 2023, estimating over 300 participants. Polymer Meeting 15 will also apply for the IUPAC and EPF endorsements to achieve global recognition.

Polymer Meeting 15 is a non-profit scientific meeting and PISAS seeks a financial support from sponsor partners to successfully provide a conference of the highest level while keeping registration fees as low as possible. MATTEK kindly decided to support Polymer Meeting 15 as a Silver Sponsor and will also participate as an Exhibitor under the terms of this Agreement.

The parties therefore agree on the following:

1. Subject matter of this Agreement

1.1 MATTEK will support Polymer Meeting 15 as a Silver Sponsor and Exhibitor.

1.2 The Silver Sponsor sponsorship package will consist of:

- a) MATTEK's promotional materials can be provided on a desk at the entrance;
- b) MATTEK's logo will be displayed on the conference website, on every page of the conference website, and in the book of abstracts
- c) MATTEK will receive full contact details for all conference participants (Name, Company, email)
- d) MATTEK can put promotional material into the conference bag;
- e) MATTEK's logo will be displayed on the slides between the scientific sessions.

1.3 The Exhibitor's booth package will consist of:

- a) One larger booth, size 4 x 2 m

- b) Application presentation during a scientific session (contributed lecture)
- c) Workshop option offered to the participants on the registration webpage
- d) Waived registration for 1 participant

2. Guarantee and liability

- 2.1 PISAS will conduct all the tasks under the terms of this Agreement with the greatest care that MATTEK is properly represented as a Silver Sponsor and Exhibitor at the Polymer Meeting 15.
- 2.2 The conference chair Prof. Igor Lacik will guarantee that the Silver Sponsor package and the Exhibitor booth will be provided to MATTEK under the terms of this Agreement.

3. Remuneration

- 3.1 PISAS shall receive EUR 3,500 (in words: three thousand and five hundred Euro) as a Silver Sponsor and Exhibitor at Polymer Meeting 15.
- 3.2 MATTEK will pay the remuneration agreed in Section 3.1 by wire transfer to a bank account to be specified by PISAS.
