Subject of the contract

The subject matter of this Agreement is the cooperation of its parties in the following:

a lecture with discussion for students of Academy of Music and Performing Arts Bratislava (VŠMU) and Slovak theatre professionals

Of Experts on Stage and Co-Producing Spectators. 20 years theatre of Rimini Protokoll

(hereinafter only "event")

which will be realized by Imanuel Schipper for The Theatre Institute Bratislava on 07th May 2019 at 5.00 p.m. in the space of Theatre Studies Department of Academy of Performing Arts Bratislava.

The rights and liabilities of contractual parties

1st Party to this Agreement is obliged:

- 1. to provide and cover the accommodation for the 2nd Party to this Agreement during 06th May 08th May 2018 (1/1 for 2 nights),
- 2. to provide the 2nd Party to this Agreement with fee of 500,00€ (five hundred Euros),
- 3. to cover a flight ticket for the 2nd Party to this Agreement as follows: on May06th, 2019 from Hamburg to Vienna and on May08th from Vienna Hamburg and provide or cover the transportation costs from Vienna to Bratislava from Bratislava to Vienna.
- 4. to provide interpretation from English to Slovak language for the event,
- 5. to provide promotion of the event.

2nd Party to this Agreement is obliged:

- 1. to prepare, attend and take part in the event and the length of the event should be up to 90 120 minutes,
- 2. to give allowance to make a record the event
- 3. to give allowance public distribution of the copy of recordings of event for the purposes of the archive and for educational and research use only
- 4. to obliges to send an expanded draft of the event in electronic form not later than 20th April

Final provisions

- 1. The contractual parties agree to provide the necessary cooperation at fulfilling of this Agreement.
- 2. This Agreement is concluded for a definite period. The agreement shall become effective on the day following its publishing in the Central Register of Contracts and shall close on May 12th, 2019. The fee is due after receiving and invoice from the 2nd Party and payable not later than by June 12th, 2018.
- 3. This Agreement becomes valid on the day of its signing by both sides and comes into effect on the day following its publication in the Central Registry of Contracts in Slovakia.
- 4. According to the valid income tax act, the author will fulfil his tax liability in his country.
- 5. This Agreement is executed in two copies, each copy having the effect of the original. Each Party to this Agreement shall receive one copy of this Agreement after it is signed.
