LICENCE AGREEMENT made this 13th of February 2023

BETWEEN

Martin Yates, France ('the Licensor')

AND

Slovak National Theatre , Pribinova 17, 819 01 Bratislava. Slovak Republic (the 'Licensee')

Martin Yates has hereby agreed to Licence to the Slovak National Ballet his orchestral arrangement of Jules Massenet's music (the 'Arrangement') for Kenneth MacMillan's ballet Manon ('the Production') for the following performances with live orchestra ('the Performances') at the Slovak National Theatre:

22nd March 2024
23rd March 2024
26th March 2024
27th March 2024
6th April 2024

In consideration of the above, the Licensee shall pay to the Licensor a royalty of 2% (two per cent) of the Gross Box Office Receipts. This royalty shall be accounted for no later than 14 days after the last performance and paid no later than 21 days after the last performance, subject to receipt of invoice.

The granting of this Agreement allows for no alteration to the Arrangement by anyone other than the Licensor, his representatives or descendants.

The Licensee hereby confirms that the Arrangement is only for use in the Performances of Kenneth MacMillan's ballet Manon and will not be recorded or broadcast on any means now or hereafter known without the prior written agreement from the Licensor and subject to a separate agreement. Notwithstanding, the Licensor hereby allows the recording of

Performances and rehearsals for archival purposes, news and promotional footage, providing that the excerpts used do not exceed five minutes in length.

The Licensee agrees that the Licensor will be credited on all programmes and publicity materials and that wherever a credit appears for Kenneth MacMillan, further credits will appear as follows:

Music	Jules Massenet
Arranged and Orchestrated	Martin Yates

The Licensee shall make available to the Licensor two top price complimentary tickets for a performance of the Licensor's choice.

The Licensee acknowledges that the full scores, orchestral materials and piano rehearsal scores are to be hired under a separate agreement from The Royal Opera House, Covent Garden.

This Agreement shall be construed in accordance with the Law of, and the parties hereby submit to the non-exclusive jurisdiction of the Courts of England and Wales.

This Agreement enters into effect on the date of its signing by both parties and on the day following the date of its publication in accordance with the special regulation (Act No. 211/2000 Coll. on free access to information) in accordance with legislation in the Slovak Republic. The Licensor agrees to the publication of this Agreement.
