have agreed to conclude this contract under the following conditions:

Art I.

Subject of the agreement

- 1.1. By this agreement, the parties to this agreement undertake to cooperate in the preparation and implementation of the Contemporary Drama Festival Nová dráma/New Drama 2023 in the period of **May 14th - May 18th 2023**, what covers the participation in the main, accompanying and working programme of the festival.
- 1.2. By this agreement, the participant No 2, undertakes to ensure participant No.1 agreed tasks.

Art. II.
The duties of parties of this Agreement

- 2.1. By this agreement, participant No.1, as the organizer of a professional theatre event, undertakes to ensure participant No. 2
- 2.1.1. To cover the accommodation with the breakfast for the 2nd Party to this Agreement during May 14th -18th 2023 (1/2 for 4 nights in Art Hotel William in Bratislava together with the spouse theatre expert Oksana Mysina).
- 2.2. By this agreement, the participant no. 2, undertakes to ensure participant no.1 **contribution at the international event Focus Ukraine, presentation of the Ukrainian drama publication** and other agreed tasks in the frame of accompanying and working programme of the Nová dráma/New Drama Festival. Any other financial settlement is not the subject of this agreement.

Art. III.
Final provisions

- 3.1. This Agreement becomes valid on the day of its signing by both sides and comes into effect on the day following its publication in the Central Registry of Contracts at the Government Office of the Slovak Republic
- 3.2. The agreement is issued in two originals and each contracting party obtains one exemplar.
- 3.3. All changes and amendments to this contract can be made only by mutual agreement and must be put in written form and must be agreed and signed by persons authorized to act on behalf of both the contracting parties.
- 3.4. All issues not covered by this Agreement are to be governed by the relevant provisions of the law of the Slovak Republic.
- 3.5. The parties to this Agreement declare that they read the agreement, understood the statutes of the agreement and those are a demonstration of their real serious and free will confirming it by their vet-ink signature.
