Annex 2 Original Article 1 - Role of partner Acting for Climate

The purpose of the proposal is to improve youth work and children leisure time activities in and around Jelšava as set out in the Slovak Youth Strategy by revitalizing the historical monument of the Redoute Skalka (Activity 1), by establishing and operating a Youth Centre (Activity 2), by supporting Youth Work and Social Field Work (Activity 3) and conceptual youth work (Activity 4) and organizing an International Exchange with the aim to establish an Artist Residency programme (Activity 5).
