# GENERAL TERMS AND CONDITIONS OF SALES

### 1. Terms of Sale

These Terms and Conditions of Sale ("Terms of Sale") govern all sales of products or equipment (collectively the "Products") by Groupe ADP to Buyer, following the issuance of a purchase order (the "Purchase Order").

Upon receipt by Buyer of an express acceptance or order acknowledgment from Groupe ADP, the Purchase Order terms and conditions specifying the identity, price and quantity of the Products, as modified by Groupe ADP order acknowledgment, upon these Terms of Sale becomes a binding agreement between Buyer and Groupe ADP (the "Sales Agreement"); provided, however, that any other Purchase Order terms and conditions, including any terms and conditions of the Buyer, that conflict with or are in addition to these Terms of Sale, are not applicable and these Terms of Sale shall exclusively govern the Sales Agreement. In the event the Purchase Order conflicts with Groupe ADP's order acknowledgment, Groupe ADP's order acknowledgment prevails.

### 2. Price

All amounts stated are net of prices and without VAT. The prices of the Products, as set forth in Groupe ADP quotation or order acknowledgment, do not include sales, use, excise or any other taxes or assessments levied by any local or foreign authority, unless Groupe ADP agrees otherwise in a signed writing.

### 3. Payment

Payments must be made to Groupe ADP in EURO within fifteen (15) days of the date of Groupe ADP proforma invoice, unless Groupe ADP expressly agrees otherwise in a signed writing. Payments not received when due shall bear interest at the lower of ten percent (10%) per annum or the maximum rate allowed by applicable law. Buyer agrees that in the event that payment by Buyer for any Products including, but not limited to, equipment, has not been received by Groupe ADP when due, Groupe ADP shall have the right, in addition to any other rights of Groupe ADP: (i) to repossess any Products including, but not limited to, equipment, of the same type up to the value of any Products for which payment has not been received by Groupe ADP when due and/or to require Buyer to return, at Buyer's cost and risk, such Products to Groupe ADP; and/or (ii) to suspend any future deliveries of Products to Buyer until payment is made in full.

However, as part of this sale:

- 50 % of the amount within 10 days of conclusion of the contract a 50 % within 15 days of delivery of the Goods.



### 4. Delivery

Groupe ADP will deliver the Products EXW - Ex Works Groupe ADP's plant (INCOTERMS 2010), unless Groupe ADP expressly agrees otherwise in a signed writing. Buyer shall pay all transportation costs of the Products. Groupe ADP will endeavor to meet the delivery date(s) provided by Buyer. If Groupe ADP anticipates that he will not be able to meet such date(s), Groupe ADP shall forthwith notify the Buyer thereof in writing, stating the reason, and, if possible, the time when delivery can be expected. Buyer has no claim for damages resulting from any such delay in delivery, unless Groupe ADP expressly agrees otherwise in a signed writing. The Buyer shall collect the Products within thirty days (30) days of them being made available. Without limitation to Groupe ADP's any other rights, if the Buyer has not collected the Products within seven (7) days after the expiry of the said period of thirty (30) days, the transaction will be void and Groupe ADP will be entitled to resell or otherwise dispose of all part of the Products.

However, as part of this sale, Seller will deliver the Products DAP- Delivered at place (INCOTERMS 2010)

The Seller will deliver 2 pcs of Deicing trucks at the week 43 of the year 2023 and 1 pc of Deicing truck not before week 51 of the year 2023.

The Seller will provide training for the Buyer's employees directly after the delivery of the first two Products.

### 5. Title, Retention of Title and Risk of Loss

Title to the Products passes to Buyer when the Products are fully paid for. The Buyer shall at the request of Groupe ADP assist him in taking any measures necessary to protect Groupe ADP's title to the Product. All risk of loss of the Products passes to Buyer when the Products are made available for transportation by the carrier.

### 6. Warranty

Groupe ADP hereby warrants to the Buyer that Groupe ADP owns the Products without restriction and free from any charge, mortgage, lien or other encumbrance. The Buyer agrees that the Products are being sold in an "as is" condition save where any of the Products are stated to be sold in an "as refurbished" condition in which event the Purchaser accepts such Products in such refurbished condition. To the fullest extent permitted by law, Groupe ADP expressly disclaims, and are excluded from this Sales Agreement, all other warranties, whether expressed or implied, including but not limited to, any implied warranty of merchantability of fitness for any particular purpose or as to the condition or working order of the Products including any latent defects. Groupe ADP does not assume or authorize any other person to assume on its behalf, any liability in connection with the sale of the Products.

However, as part of this sale, Seller grands a 6 month guarantee on labor, interventions, and spare parts of less than 25.000€ (twenty-five thousand euros).

### 7. Limitation of Liability

NOTWITHSTANDING ANY OTHER PROVISIONS HEREOF, IN NO EVENT SHALL GROUPE ADP BE LIABLE TO BUYER FOR ANY INCIDENTAL, SPECIAL, PUNITIVE, EXEMPLARY OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, ALL DIRECT AND INDIRECT LOST PROFITS, REGARDLESS OF WHETHER THOSE DAMAGES WERE FORESEEABLE. GROUPE ADP HEREBY DISCLAIMS ANY LIABILITY, WHETHER IN CONTRACT OR IN TORT (INCLUDING NEGLIGENCE AND STRICT LIABILITY), FOR ANY DAMAGE ARISING OUT OF, RELATING TO OR CAUSED BY BUYER'S USE OF GROUPE ADP'S PRODUCTS.

TO THE MAXIMUM EXTENT ALLOWED BY LAW, BUYER SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS GROUPE ADP AND ITS EMPLOYEES AND AGENTS AGAINST ALL SUMS, COSTS, LIABILITIES, LOSSES, OBLIGATIONS, SUITS, ACTIONS, DAMAGES, PENALTIES, FINES, INTEREST AND OTHER EXPENSES (INCLUDING, BUT NOT LIMITED TO, INVESTIGATION EXPENSES AND ATTORNEYS' FEES) THAT GROUPE ADP MAY INCUR OR BE OBLIGATED TO PAY AS A RESULT OF BUYER'S USE, OWNERSHIP, MAINTENANCE, TRANSFER, TRANSPORTATION OR DISPOSAL OF THE PRODUCTS.



### 8. Termination

In the event of a breach by Buyer of the Sales Agreement including, but not limited to, any insolvency or bankruptcy of Buyer, Groupe ADP may immediately terminate the Sales Agreement, upon giving written notice of termination to Buyer. If the Sales Agreement is terminated by Groupe ADP for Buyer's breach, Groupe ADP is entitled to reimbursement for any labor, material or other reasonable expenses incurred in connection with the Sales Agreement, plus Groupe ADP's normal overhead. The provisions of Section 11 shall survive the expiration or earlier termination of the Sales Agreement.

#### 9. Force Majeure

Groupe ADP shall not be liable for delay in delivery of Products, or for any other interruption, delay, loss or damage which is incurred or suffered as a result of a Force Majeure, and Groupe ADP's obligations hereunder shall be excused and suspended during the period such Force Majeure remains in effect. "Force Majeure" shall mean a condition or cause beyond the reasonable control of Groupe ADP including, but not limited to, acts of God, floods, earthquakes, hurricanes, tornadoes or other severe weather conditions; acts of public enemy, war, blockade, insurrection or riot; fire, wreck or explosion; strike, lockout or labor dispute; embargoes; act of governmental authority or compliance with governmental laws, orders or regulations; plant shutdown; equipment failure; delays, shortages or failure of the supply of parts or components; shortage of energy or transportation; or circumstance beyond Groupe ADP's reasonable control not enumerated in the foregoing which reasonably shall prevent Groupe ADP from performing its obligations hereunder in the normal course of Groupe ADP's business.

### 10. Confidentiality, Intellectual Property

Buyer agrees to hold as confidential and not disclose or divulge to any third party any confidential information received from Groupe ADP including, but not limited to, prices, trade secrets, technological know-how, specifications and the terms of the Sales Agreement, unless Groupe ADP gives its prior written approval. Unless otherly agreed, Groupe ADP is not granting to Buyer in the Sales Agreement any right, title or interest in or to any of its intellectual property rights including, but not limited to, any patent, copyright, or trade names, all of which are exclusively owned by and reserved to Groupe ADP. Buyer agrees to return all confidential information to the Groupe ADP at its first request.

### 11. Business Conduct and Compliance

Groupe ADP and Buyer, each as a party to this Sales Agreement, shall comply with all applicable laws and regulations relating to anti-bribery, anti-money laundering and anti-corruption including such applicable laws and regulations. Each party warrants that it has not offered any form of bribe, inducement or other incentive to the other party in return for entering into this Sales Agreement. Each party shall not (and will take all reasonable steps to ensure that its personnel, agents, representatives or sub-contractors or any other person acting on its behalf shall not) accept, solicit, agree to receive, promise, offer or give a bribe, facilitation payment, kickback or other improper payment. The parties shall notify each other immediately upon becoming aware of any actual or potential breach of the provisions of this clause.

The Buyer warrants that it is not (i) a natural person or entity which is subject to trade sanctions imposed by domestic or international government authorities, such as those adopted by the United Nations, the European Union or the United States ("**Trade Sanctions**"); or (ii) a natural

The Buyer will not make the Products available either directly or indirectly (i) to natural persons or entities which are subject to Trade Sanctions; or (ii) to natural person or entities which are owned (more than 50%) or controlled by individuals or entities subject to Trade Sanctions.

The Buyer hereby gives written assurance that it will comply with all such export controls and sanction laws and regulations and that it bears sole responsibility for any violation of such laws and regulations, and that it will indemnify, defend, and hold Groupe ADP harmless for the consequences of any such violation.

The Sales Agreement may not be altered or modified except by the signed written agreement of Groupe ADP and Buyer.

### 14. Governing Law

The validity, construction and performance of the Sales Agreement is governed by and shall be construed in accordance with the laws of France. Buyer hereby irrevocably submits and agrees to the jurisdiction of the courts of Bobigny, France in any action, suit or proceeding related to, or in connection with, the Sales Agreement.

### 15. Personal Data Notice

Groupe ADP undertakes to process the personal data communicated by the Buyer in accordance with the applicable regulations and its general privacy policy.

Any personal data provided by the Buyer will be processed by Groupe ADP, the controller, for the following purposes: (i) to communicate with the Buyer, (ii) to take steps prior to entering into a contract with the Buyer, (iii) to manage the contractual relationship, (iv) to perform Groupe ADP's obligations under this Sales Agreement, (v) to comply with any legal or regulatory obligations, (vi) to ensure customer relationship management, (vii) to improve the quality of



Groupe ADP's products and services and (viii) to market, promote and sell GROUPE ADP products and services.

The Customer remains solely responsible for processing personal data supplied to Groupe ADP. By transmitting personal data to Groupe ADP, the Customer confirm that it has obtained the data in a regular and legitimate manner.
