the Germanisches Nationalmuseum shall borrow the objects set out on Appendix 1

from: 01.07. 2024

to: 17.01.2025

including outward and homeward transport, construction and dismantling.

The loan shall be subject to the following conditions:

1. The costs of the packaging and transport in both directions, and customs clearance of the objects on loan and any costs of escorting the transport shall be borne by the Germanisches Nationalmuseum.
2. The Germanisches Nationalmuseum shall exercise the care of the objects on loan, which is necessary and customary among museums "from nail to nail", protect them against damage and not expose them to any risk.
3. The objects on loan shall be used only for the approved purpose.
4. The Germanisches Nationalmuseum will without delay notify the Lender of any and every damage or alteration that is observed to the objects on loan and, provided there is not further danger in delay, will await the Lender's directions.
5. Unless the Lender itself effects insurance or desires another solution, the Germanisches Nationalmuseum will take out nail-to-nail insurance with Kuhn & Bülow.
6. The Germanisches Nationalmuseum shall be entitled to make photographs and recordings of

the objects on loan, unless the Lender expressly prohibits this. Television recordings shall be permitted only for the purpose of information (report on the exhibition).

7. The Borrower shall designate the Lender's objects in the exhibition, in the catalogue, and in all other publications as follows:

Zemplínske Museum, Michalovce, Slovakia

The Lender shall receive three complimentary copies of all catalogues, posters, or similar publications that are produced in connection with the exhibition.

8. The following points are also agreed:

9. All alterations or additions to this agreement must be in writing to be valid. No oral collateral agreements have been entered into.

The Lender and the Borrower shall each receive one official copy of this agreement.

Any disputes arising under this agreement shall be governed by law of the Federal Republic of Germany.

The place of jurisdiction for all disputes arising under this agreement shall be Nürnberg.

Except where this agreement contains specific provisions, the provision of the Civil Code of the Federal Republic of Germany shall apply.

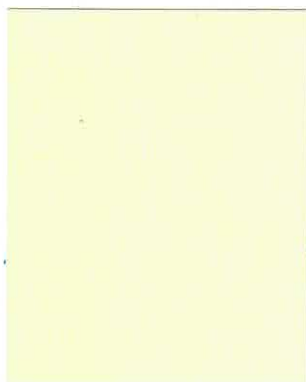
