Institution's Responsibilities

In accordance with the terms and conditions stated herein and in the Annexes hereto the Institute of Neuroimmunology Slovak Academy of Sciences, Bratislava, Slovakia

(hereinafter referred to as the "Institution"), shall provide for the full and proper performance of its obligations under this Agreement, all the services described in the Terms of Reference dated 16 May 2024.

A copy of the Terms of Reference is attached hereto as Annex B and made a part hereof. All work required under this Agreement shall be completed no later than 31/05/2025.

Financial Participation of ICGEB and Payments

ICGEB shall pay the Institution for the full and proper performance of all obligations hereunder the sum of Euro Twelve Thousand only------ (Euro 12,000). ·---- (Euro 12,000).

This sum shall cover all expenses incurred by the Institution as per Part 2 of the Terms of Reference (Annex B).

The Institution shall not do any work which may result in any charges to ICGEB over and above the sum of Euro Twelve Thousand only--------- (Euro 12,000) without prior written consent of ICGEB and a formal amendment to the Agreement.

Entry into Effect of the Agreement
This Agreement shall be deemed to be effective from the date of signature of this Agreement by both ICGEB and the Institution, collectively referred to as "Parties".

The Institution shall prepare and submit to ICGEB the reports which are listed below, together with the related statement of expenditures and invoice whenever necessary. The reports shall be prepared in conformity with Annex C entitled "Annual Progress Report" and Annex D entitled "Final Report", whichever is applicable, and in conformity to paragraph 5 of Annex A entitled "ICGEB General Conditions of Agreement".

a) A Final Report, in English, covering the overall work performed in accordance with paragraph 2, no later than 30/06/2025. Please note that any new research proposal under the ICGEB CRP Programme originating from the Principal Investigator will be considered only upon receipt and approval of the Final Report.

Payment

Payment shall be made in accordance with paragraph 3 on the basis of the Institution's invoices prepared in conformity to Annex E entitled "Sample Invoice" rendered as follows:

a) upon execution of the Agreement by both Parties, and submission of the related invoice the sum of Euro 12,000

The making of any payment hereunder by ICGEB shall not be construed as an unconditional acceptance by ICGEB of the work accomplished by the Institution up to the time of such payment. All payments under this Agreement shall be made by ICGEB by bank transfer to the account(s) of the Institution indicated in the invoice and in accordance with paragraph a) above.

7. <u>Submission of Invoices</u>
For each payment requested, the Institution shall submit invoices to ICGEB in conformity to Annex E, on the headed paper of the Institution and with the proper signature(s).



8. General Conditions

The parties hereto agree to be bound by the ICGEB General Conditions of Agreement, copy of which is attached hereto as Annex A.

It is understood that all necessary arrangements to comply with national regulations relating to this Agreement and relevant to the Institution's responsibilities shall have been undertaken by the Institution. Failure to do so will nullify this Agreement. The responsibility of ICGEB is limited to the financial support specified in this Agreement.
