**have agreed to conclude this Agreement under the following conditions:**

### Article I

#### Subject of the Agreement

- 1.1. Contracting Parties undertake to cooperate in the preparation and implementation of the Nová dráma/New Drama 2024 Festival from **15 May 2024 to 18 May 2024**. This period covers the participation in the main programme, accompanying programme, and working programme of the festival.
- 1.2. The Participant No. 2 undertakes to accomplish the tasks as agreed with the Participant No. 1.

### Article II

#### Rights and duties of the Contracting Parties

- 2.1. The Participant No. 1, as the organizer of a professional theatre event, undertakes to:
  - 2.1.1. to settle the accommodation costs of the Participant No. 2. The Participant No. 1 shall provide the Participant No. 2 with accommodation with breakfast in Art Hotel William (Laurinská 17, 811 01 Bratislava) for 3 (three) nights (from 15 May to 18 May 2024).
- 2.2. The Participants No 2 undertakes to accomplish the tasks as agreed with the Participant No.1 within the accompanying and working programme of the Nová dráma/New Drama 2024 Festival. The Participant No. 2 agrees to perform the agreed tasks without remuneration or other compensation.

**Article III**  
**Final provisions**

- 3.1. This Agreement comes into force on the day of its signing by both Contracting Parties and becomes effective on the day following the day of its publication in the Central Register of Contracts of the Government Office of the Slovak Republic.
- 3.2. The Agreement is signed in duplicate, each copy having legal force of the original, and each Contracting Party shall receive one copy.
- 3.3. All changes and amendments to this Agreement shall be made only after mutual agreement and must be concluded in the form of a written amendment signed by persons authorized to act on behalf of the Contracting Parties.
- 3.4. Relationships that are not governed by this Agreement shall follow the relevant provisions of the law of the Slovak Republic.
- 3.5. Contracting Parties hereby declare that they have read this Agreement, understood its content, agree therewith and enter into the Agreement freely, with serious intentions and without duress. In witness thereof they sign the Agreement.
