

**AGREEMENT No. 2024 B2B/17-09**

Limited liability company **B2B Baltic Travel** (Reg No LV40103624464), which represented by its Member of the Board **Agnese Zāle** acting by statute (herein after referred to as **"Company"**) on the one hand and **SLOVAKIA TRAVEL** represented by its General Manager Ivana Vala Magátová (herein after referred to as **"Customer"**) on the other hand conclude an agreement on following:

**1. Subject of agreement**

- 1.1. **"Customer"** agrees to take a part at Travel Trade Roadshow in the Baltic countries **"TTR Baltic"** in November 12-14, 2024 under the **Destination Slovakia** meeting outbound travel industry from all three Baltic countries

**November 12 / Lithuania.** Venue at ARTIS Centrum Hotel, Liejyklos street 11/23, LT 01120, Vilnius

**November 13 / Latvia.** Venue at Radisson Blu Hotel Latvija Conference & Spa Hotel, Elizabetes street 55, LV 1010, Riga

**November 14 / Estonia.** Venue at Swissotel Tallinn, Tornimäe 3, EE 10145, Tallinn

**Space rental fee** for all three Baltic countries (Lithuania, Latvia and Estonia)  
**12 sq m for Destination Slovakia in total - EUR 8800 excluding VAT**

- 1.2. The **"Customer"** pays the invoice written out by the **"Company"** within 12 calendar days from the moment it has been received.
- 1.3. **"Company"** undertakes the responsibility of full event arrangement, invite the travel industry in each Baltic country.

**2. Duration of a contract and handling of disputes**

- 2.1. Parties agree with the publication of the agreement by SLOVAKIA TRAVEL in the Central Register of Contracts kept by the Government Office of the Slovak Republic in accordance with § 47a sec. 1 of Act no. 40/1964 Journal of the Civil Code, as amended, in connection with § 5a sec. 1 and 6 of Act no. 211/2000 Coll. On Free Access to Information and on Amendment to Certain Acts (Freedom of Information Act), as amended. The Agreement shall enter into force on the day of its conclusion and shall enter into effect the day after of the publication.
- 2.2. The parties are eligible to terminate the agreement if they both agree on that in a written way.

- 2.3. All disputes and disagreements have to be settled by negotiations, but if no agreements can be reached, the dispute will be settled in accordance with the legislation of the Republic of Latvia.
- 2.4. All amendments and additional things to this agreement shall be done in writing and shall take effect upon signing.
- 2.5. The agreement is made and signed in two copies, one for each contracting party.
