Ministry of Environment of the Slovak Republic Namestie L. Stura 1 812 35 Bratislava Slovakia

("the coordinating beneficiary"), represented for the purposes of signature of this grant amendment by Jan Budaj, the Minister of Environment of the Slovak Republic

of the other part,

WHEREAS

(1) The grant agreement No. **LIFE18 IPE/SK/000010**, hereinafter referred to as "the grant agreement", entered into force on 8 November 2019,

(2) The associated beneficiaries: The Bratislava Self-Governing Region (BSK) and Centre for Sustainable Alternatives (CEPTA) have been added to the Grant Agreement,

(3) Annex II to the grant agreement (description of the action) has been revised,

(4) Annex III to the grant agreement (estimated budget of the project) has been revised,

(5) Annex IV to the grant agreement (mandates provided to the coordinating beneficiary by the other beneficiaries) has been revised,

(6) The coordinating beneficiary has the mandates of all associated beneficiaries participating in the grant agreement for the purpose of the signature of this amendment.

Have agreed as follows:

Article 1

The grant agreement **LIFE18 IPE/SK/000010** (hereinafter referred to as "the grant agreement") is modified as follows:

(3) The Ministry of Environment of the Slovak Republic joins the project as of 01/01/2022 as co-financer established in Slovak Republic becoming responsible for the implementation of the actions indicated in form A6 attached.

(4) Annex II to the grant agreement (description of the project) is replaced by the Annex IIbis attached to this amendment.

(5) Annex III to the grant agreement (estimated budget of the project) is cancelled and replaced by Annex III-bis attached to this amendment.

(6) The mandates of The Bratislava Self-Governing Region (BSK) and Centre for Sustainable Alternatives (CEPTA) are added to Annex IV to the grant agreement (Mandates provided to the coordinating beneficiary).

Article 2

With the exception of the modifications introduced by the present amendment, all other provisions of the grant agreement remain in full force. This amendment No. 1 forms an integral part of the grant agreement.

This amendment will enter into force on the day of the last signature of the parties to the grant agreement.
