## Article I. Subject and purpose of the contract

The subject of the contract is a one-time financial contribution (hereinafter referred to as a "gift"), which the Donor gives to the Donee in the manner specified in Art. II of the Agreement and the Donee accepts this gift with gratitude. The gift is purposefully tied, it can only be used for the purposes specified in Art. II of this Agreement.

#### Article II. Donor commitment

- 1. The Donor contributes by donating to:
  - Reimbursement of costs necessary for the animal-raising of the selected animal,
- 2. the name of the sponsored animal: **Pygmy hippopotamus**
- 3. The Donor commites to donate a financial amount of: **700 EUR**, in words: seven hundred EUR, for the period: **01.12.2024 30.11.2025**
- 4. The Donor and the Donee have agreed on the method of payment: by transfer to a bank account no later than 7 days from the date of entry into force and effective date of this Agreement.

- 5. The Donor gives consent to the publication of his name and surname / name / business name on the website of the Donee.
- 6. The Donor gives consent to recieve information messages (ZOO news) on the given email address.

### Article III. Donee commitment

- 1. The Donee commints to use the gift for the purpose set out in Article II. of this agreement. If for some reason the selected species of animal is no longer in the zoo's custody, the Donee will inform the Donor about the situation and ask for consent for the gift to be used for another purpose. In case the Donor refuses to grant consent for another purpose, the gift will be returned to him within 30 days of written disagreement.
- 2. In the case of Donor consent pursuant to Art. II points 2 and 3 of the Agreement, publication of information on the Donor to the extent agreed in Art. II points 2 and 3 of the agreement are provided by the Donee at his own expense.

## Article IV. Final provisions

- 1. The rights and obligations of the contracting parties, unless this contract provides otherwise, are governed by the relevant provisions of the Civil Code of the Slovak republic and the provisions of related legislation of the Slovak Republic, as amended.
- 2. The contracting parties declare that they have read the Agreement, understood its content and, in order to confirm that the content of this contract corresponds to their real, serious and free will, sign it.
- 3. The Agreement is made in two copies, of which each party will receive one after signing it.
- 4. The Agreement becomes valid on the date of signing by both contracting parties and effective on 01.12.2024, but no earlier than the day following the date of its publication in accordance with section § 47a par. 1 of Act no. 546/2010 Coll., which amends the Civil Code in connection with the provisions of § 5a of Act no. 211/2000 Coll. on free access to information and on amendments to certain laws as amended.
