Memorandum of Understanding ("MOU")

Participation Contract

- Slovak Republic, represented by Ms. Ivana Vala Magatova, Commissioner General of Section, (hereinafter referred to as "the Participant"), has applied to Japan Organiser for the 2025 World Exposition represented by Mr. Hiroyuki Ishige, Secretary General of Japan Organiser for the 2025 World Exposition, (hereinafter referred to as "the Organiser"), to rent, for a fee, the exhibition space provided by the Organiser, and the Organiser agrees the request of the Participant.
- 2. The Participant and the Organiser shall amend Article 2 of the Participation Agreement concluded on March 31 2023, as follows:

The Organiser provides space at the disposal of the Participant, which the Participant hereby accepts, as designated on the plan annexed to the Contract as Appendix I and made up as follows:

•Exhibition space of 80.37 square meters which shall be handed over by the Organiser, at a rent of USD 1,143.25 per square meter for the area excluding commercial activity space.

Spaces will be provided for the Participant as follows:

•The entry of items to be exhibited shall be authorized as from 13 November 2024.

The Participant agrees to present an exhibition related to the theme of the Expo as described in the General Regulations and in Special Regulation No. 1. The Participant shall set up an exhibition as described in the Theme Statement approved by the Organiser and attached to this Contract as Appendix II, which constitutes an integral part hereof.

In accordance with the General Regulations and the Special Regulations, the Participant shall be responsible for the decoration, maintenance, management and cleaning of the spaces at its disposal.

- 3. The rent shall be paid at 50% of the total amount by the time of delivery of the exhibition space, with the reminder to be paid by March 13, 2025.
- 4. The Appendix I attached to the Participation Contract concluded on March 31 2023, shall be rendered null and void, and the Appendix I attached to this MOU shall be the document that specifies the space referenced in Article 2."




