


Description:	Our five-day B2 intermediate English course in Seville is tailored for adults, especially Erasmus+ teachers seeking to enhance their English language skills in an immersive environment. Participants will engage with a variety of authentic materials, including articles, podcasts, and discussions on relevant topics. Through interactive activities, role play, and group work, learners will develop their vocabulary and refine their grammar while practising conversational skills. Set against the vibrant backdrop of Seville, this course encourages both personal and professional growth.

Interactive grammar exercises and group discussions to reinforce understanding. ○ Module 3: Develop listening skills through authentic materials like podcasts and videos. Complete comprehension tasks and participate in group discussions based on listening exercises. ○ Module 4: Enhance writing skills for various contexts, including emails and short essays. Write and peer-review pieces to improve clarity and structure. ○ Module 5: Emphasise conversation skills and cultural understanding. Role play discussions on cultural topics, fostering fluency and confidence.
