(Donor and Donee hereinafter jointly referred to as the "Contracting Parties" or individually as the "Contracting Party")

are concluding this Agreement of Donation (hereinafter referred to as the "Agreement") pursuant to the provisions of Section 628 et seq. of Act No. 40/1964 Coll. of the Civil Code, as amended (hereinafter referred to as the "Civil Code").

Article I Subject of the Agreement

The Donor donates to the Donee a non-financial donation (laboratory equipment) worth EUR 300.00 (in words: three hundred EUR), obtained within the Micro-Hunters project with the content as follows:

- 1 pc. PSF 250ml Thermo Scientific TM 300-400 filtration device;

Article II Declarations of the Parties

- 1. The Donor hereby transfers to the Donee a non-financial donation worth EUR 300.00 (in words: three hundred EUR), free of charge, as specified in Article I of this Agreement.
- 2. The Donor declares that he is not aware of any factual or legal defects in the object of the donation that they should have notified the Donee of before the conclusion of the Agreement.
- 3. If the Donor's declaration referred to in point 1 of this Article of the Agreement proves to be untrue, the Donee shall have the right to withdraw from the Agreement.
- 4. The Donee declares that they are aware of the condition and properties of the object of the donation, as they personally and in detail inspected it before signing this Agreement.
- 5. The Donee acquires the object of gift under this Agreement.
- 6. The Donee agrees to display publically the information about the acquisition of the object of the Agreement with the image of the project logo according to the instructions sent in advance.

Article III Final Provisions

- 1. By signing this Agreement, the Agreement Parties confirm that the Donor donated the object of donation to the Donee.
- 2. The Agreement is drawn up in two counterparts, of which each Contracting Party shall receive one copy.
- 3. Legal relations not expressly regulated by this Agreement shall be governed by the relevant provisions of the Civil Code.
- 4. This Agreement may be amended or supplemented only by written amendments signed by both authorized representatives of the Contracting Parties.
- 5. The Parties to the Agreement declare that this Agreement is a manifestation of their free and serious will, they have understood the content of the Agreement, the Agreement was not concluded under duress, in distress under noticeably disadvantageous conditions, which they confirm with their signatures.
- 6. The Agreement shall enter into force on the day of its signing by the Contracting Parties and shall take effect on the day following the day of its publication in the Central Register of Contracts.
