General provision

The parties to this Agreement declare that they are legal entities qualified to conclude this Cooperation Agreement.

I Subject of the contract

The subject matter of this Agreement is the cooperation of its parties in the following:

preparation and realisation of the masterclass for playwrights

(hereinafter only "event")

during the Nová drama/New Drama Festival 2013. The masterclass will be held on 16 May 2013 in Bratislava, together with the individual meetings with playwrights on 13-19 may 2013, including the participation at Theatre Triathlon, providing that the 1^{st} Party to this Agreement is organizer and the 2^{nd} Party to this Agreement is the lecturer of the event.

II The rights and liabilities of contractual parties

1st Party to this Agreement is obliged:

to include the event in the accompanying programme of the Nová dráma/New Drama Festival 2013,
to provide and cover the accommodation for the 2nd Party to this Agreement during 13-17 May 2013,

3. to provide and cover the travel expenses of the 2^{nd} Party to this Agreement: London / Vienna / London,

4. to provide the 2^{nd} Party to this Agreement with royalty of 500,00 \in

5. to prepare and organize the meetings with playwrights which will be held on 13-19 May 2013 in the Theatre Institute and during the Theatre Triathlon,

6. to provide the English interpretation for the event,

7. to provide the promotion of the event.

 2^{nd} Party to this Agreement is obliged:

1.to prepare, attend and lead the event: masterclass for playwrights in the length of 3 hours in English language,

2. to attend the individual meetings with playwrights provided by the 1st Party to this Agreement, during 13-19 May 2013,

3. to cover the accommodation durin 18-20 May 2013,

4. to provide the 1^{st} Party to this Agreement for promotional purpose the annotation of the event by 20^{th} March 2013 at the latest.

III Final provisions


1. The contractual parties agree to provide the necessary cooperation at fulfilling of this Agreement.
