Amendment Letter to the Administration Agreement between the Slovak Republic, acting through its Ministry of Finance and the International Bank for Reconstruction and Development and the International Development Association concerning the Multi-Donor Umbrella Facility for Capacity Development (TF071919)

#### Dear Mr. Kažimír:

- 1. We refer to Administration Agreement between the Slovak Republic, acting through its Ministry of Finance and the International Bank for Reconstruction and Development and the International Development Association concerning the Multi-Donor Umbrella Facility for Capacity Development (TF071919) (the "Trust Fund") effective as of December 17, 2012, as amended (the "Administration Agreement").
- 2. Pursuant to recent discussions between the Donor and the Bank, the Bank proposes to amend the Administration Agreement as follows:
  - (a) In Paragraph 1, in the fourth and fifth lines, a phrase "... a grant the sum of nine hundred thousand Euros (EUR 900,000) (the "Contribution" is replaced with a phrase "... a grant the sum of four hundred thousand Euros (EUR 400,000) (the "Contribution")".
  - (b) Paragraph 3 of the Administration Agreement is revised to read as follows:
  - "3. The Donor shall deposit the Contribution into such bank account designated by the Bank promptly following effectiveness of this Administration Agreement and submission of a payment request by the Bank."
- 3. All other terms of the Administration Agreement, as amended hereby, shall remain in full force and effect.

- 4. The Bank may disclose this Amendment Letter and related information on this Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this Amendment Letter, the Donor consents to disclosure of this Amendment Letter and related information on this Trust Fund.
- 5. Each of the parties represents, by confirming its agreement below, that it is authorized to enter into this Amendment Letter and act in accordance with these terms and conditions. Please confirm your acceptance of the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to the Bank. Upon receipt by the Bank of the original Amendment Letter countersigned by you, this Amendment Letter will become effective as of the date of the countersignature.
