Article 1

2. The modifications contained in the new version of the Annex entered into force on 24/05/2022.

This Addendum and the Annex accompanying it constitute an integral part of the Agreement on financing the Technical Assistance. Except from the modifications stated above, the Agreement on financing the Technical Assistance remains unchanged.
